TERMS AND CONDITIONS

Accordingly, I release all people associated with the conduct of the event from, and will indemnify them against, all liability (including liability for their negligence) for all injury, loss or damage arising out of or connected with my participation in this event.
3. I acknowledge that I can be exposed to dangerous surf conditions and that my participation in the event in which I have entered is at my own personal risk.
4. I consent to receiving any medical treatment that event organisers think desirable during or after the event. I agree to reimburse the expenses incurred in providing me with necessary medical treatment.
